France - Organization Chart

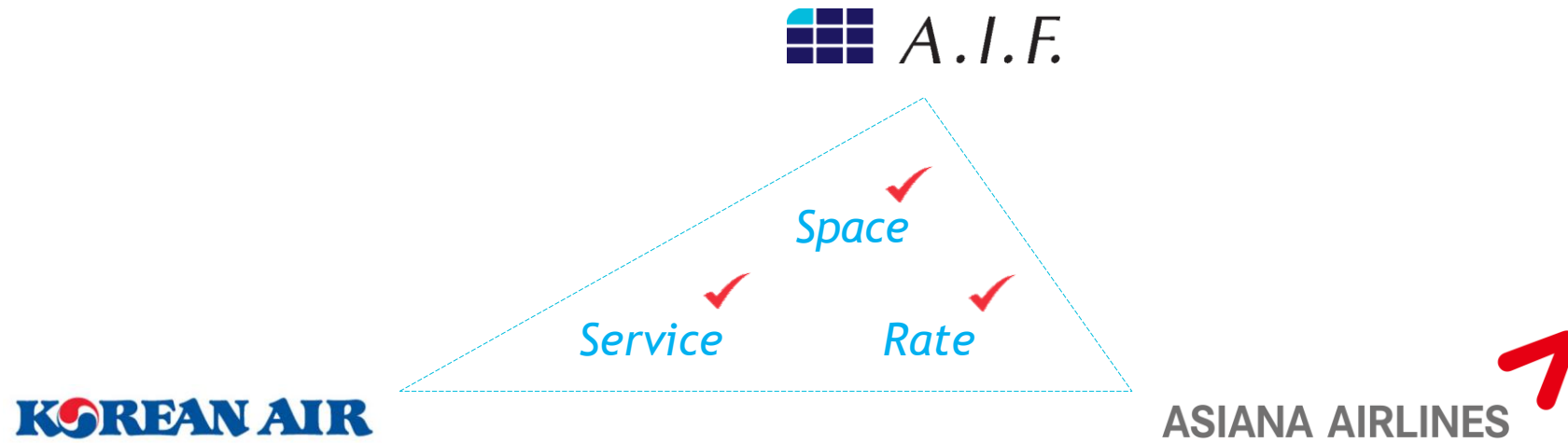

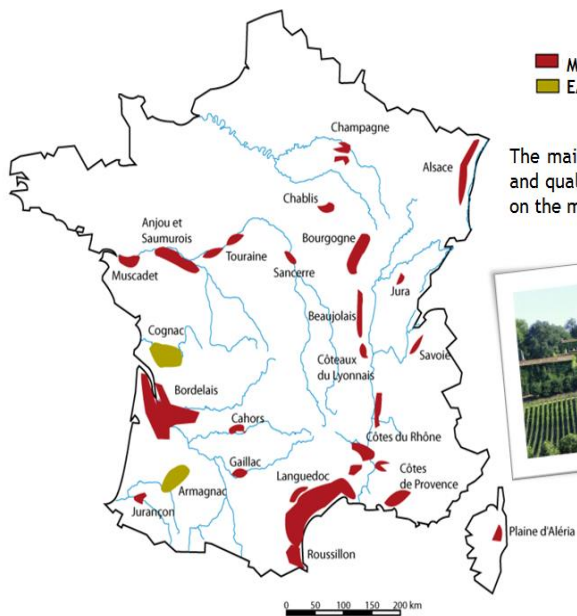

WINE PRODUCTION IN FRANCE

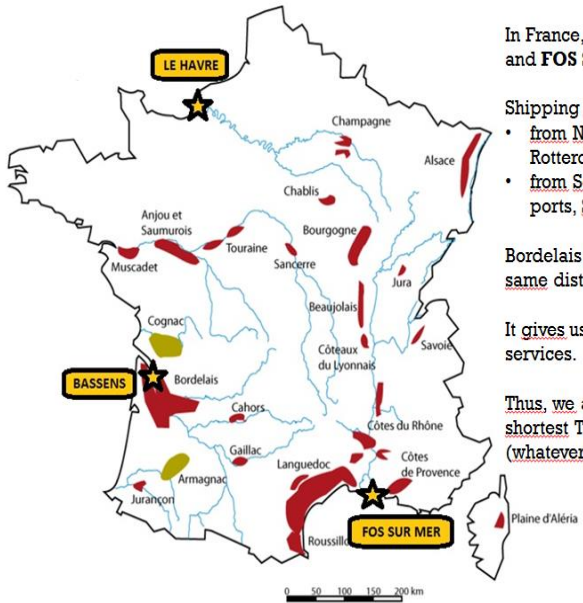


■ MAIN VINEYARD
